Authorization to Construct	When filed <u>with</u> the Improvement Permit Application	\$100.00 per site
Authorization to Construct	When filed <u>separate</u> from the Improvement Permit Application	\$160.00 per site
Engineered Option Permit	Applies to Improvement, Authorization to Construct, and Operation Permits	30% of Applicable Fee
Site Return Visit	Site not “Ready for Evaluation”	\$60.00 per visit
Building Authorization	Reuse of existing septic system (no change in system design)	\$70.00 per site
Manufactured Home Release	Reuse of existing septic system in a manufactured home park or on a private lot (no change in system design)	\$70.00 per site
Chemical or Incinerating Toilet	Type 1b or 1c Systems. <u>No Plumbing</u> in Facility	\$25.00 per site

New Private Water Supply Well	<u>Not</u> including Volatile Water Sample -	\$280.00 per site
Coliform Bacteria Water Sample	Sample for existing protected wells	\$60.00 each
Inorganic Chemical or Water Sample	Sample for existing protected wells	\$90.00 each
Sulfur Reducing Bacteria Water Sample	Sample for existing protected wells	\$90.00 each
Lead Water Sample	Sample for existing protected wells	\$90.00 each
Volatile Organic Compound, Petroleum, Pesticide or Nitrate/Nitrite Water Sample	Sample for existing protected wells	\$90.00 each
