Those that cannot present this documentation will be required to pay the temporary food establishment permit fee of \$ 75.00 and meet the required rules in order to obtain a permit.**

- 3) Purchase sealed, bottled water from a plant inspected by the NC Department of Agriculture & Consumer Services, or if the bottling plant is in another state, that states's appropriate agency.

**Definitions:**

Temporary Food Establishment - is a food establishment that operates in conjunction with and is affiliated with a transitory fair, carnival, circus, festival or public exhibition.

Regulated foods/potentially hazardous foods – An animal or plant food that has been heated or cooked and requires time/temperature control for safety to limit foodborne illness.

This includes: turkey legs, hot dogs, hamburgers, chicken, French fries, rice, beans, tomatoes, lettuce, deli meats, drinks such as real fruit smoothies, etc.

This does not include: popcorn, cotton candy, funnel cakes, elephant ears, most drinks, candy apples.

Non-profit – Means (churches, clubs, and organizations, etc.) that are incorporated as non-profit corporations in accordance with NC Department of Revenue, Chapter 55A of the General Statutes or that are exempt from federal income tax under the Internal Revenue Service, as defined in G.S. 105-228.90.
